DOPT vide its OM No.1/14/2008-IR dtd.28.07.2008 clarified that under Sub-sections (4) and (5) of section 5 of the Right to Information Act,2005 provide that a Public Information Officer (PIO) may seek the assistance of any other officer for proper discharge of his/her duties. But it has been brought to the notice of the Department that some PIOs, in contravention of the provision of the Act, transfer the RTI applications received by them to other officers and direct them to send information to the applicants as deemed PIO and thus they use the above referred provision to designate other officers as PIO.

It is thus clarified vide above referred OM that according to the Act, enables the PIO to seek assistance of any other officer to enable him to provide information to the information seeker, but does not give him authority to designate any other officer as PIO and direct him to send reply to the applicant. The import of sub-section (5) of section 5 is that, if the officer whose assistance is sought by the PIO, does not render necessary help to him, the Information Commission may impose penalty on such officer or recommend disciplinary action against him the same way as the Commission may impose penalty on or recommend disciplinary action against the PIO.

The above instruction passed by DPE is, hereby brought to the notice of all concerned to note and for future guidelines and follow up.
