No.19024/1/E.IV/2005 dtd.24.03.2006 forwarded by Min. of Water Resources under covering letter No.10/2/2006-Coord dtd.04.05.2006 whereby decision conveyed that officers entitled to air travel by National Carrier under existing order may be permitted to travel by private airlines while availing LTC as well as non-entitled officers also subject to the provisions contained in the above mentioned OMs. In pursuance of the provisions contained in the said O.Ms Air journeys by Private Airlines while availing of L.T.C. are allowed to all categories of NPCC employees viz. regular employees in CDA and IDA pattern and workmen etc. subject to the following provisions.

- 1. While availing LTC, the air journeys by non-entitled officers (both by national and private airlines) between places connected by train may be allowed, provided the reimbursement of the fare would be restricted to the entitled class by rail other than Rajdhani / Shatabdi Express. They are also required to produce the air-ticket/boarding pass and a receipt from the concerned airlines showing the fare paid by the concerned officers, if the ticket does not indicate the airfare, while claiming reimbursement of LTC".
- 2. In case the cost paid for an air ticket (in view of promotional schemes of private airlines) is less than the train fare by the entitled class, the reimbursement by the Govt. will be limited to the actual air fare or entitled train fare whichever is less.

The above concession is subject to the following conditions regarding *air travel* by Govt. servants within India during official visits would be applicable in case of LTC, mutatis-mutandis.

- i. The air travel, both domestic and overseas, on official account would now be permissible on airlines other than Air India / Indian Airlines also, provided the criteria for selecting the alternative airline for official travel are based on better and more competitive prices being offered by the other airlines. Various incentive schemes and concessional fares offered by Air India / Indian Airlines will also be fully utilized to ensure utmost economy in air travel.
- ii. The basic criteria for selecting airlines other than Indian Airlines/Air India would be better and more competitive prices being offered by the other airlines.
- iii. Various incentive schemes and concessional offered by Indian Airlines/ Air India will also be fully utilized.
- iv. Each officer who is undertaking domestic travel by air, within his entitled class, should endeavour to take advantage of the concessions being provided by the airlines, to effect possible savings vis-àvis the normal fares.
- v. Officers should try to make their bookings in advance to the extent possible, so that benefits of discounted fares can be obtained. However, the official work should not be deferred because discounted fares are not available.

- vi. Under no circumstances, should the fare exceed the normal fare of the entitled class offered by Indian Airlines/ Air India or their subsidiaries.
- vii. Individual officers are encouraged to make bookings through the internet. It would require a credit card through which payments can be made. Reimbursement of service charge expenses on such credit card would be permissible.
- VIII. Schemes offered by airlines which are co-branded with the credit cards can also be availed. However, this would need the time prior approval. However, this would need one time prior approval of the concerned Financial Adviser / Competent Authority for obtaining and utilizing such credit card.

Consequent to this delay, cases are not being settled in time and employees are facing acute financial hardship as well as Corporation is incurring losses for not timely recovery of outstanding amount from the employee concerned.

Keeping in view of the above it has been decided that ATD/ATC of the employees consequent upon their relieving on transfer, resignation and retirement etc. shall be sent along with all details to the respective Office & Units where employees are transferred, within 30 days from the date of their departure positively and visa vies responding the same by the concerned Offices & Units. In addition to that Last Pay Certificate (L.P.C) should also be sent directly to their place of posting within One month from the date of relieved of the employees. In LPC it should invariably indicate the status of their personal account and other recovery status etc. and if no recovery is there that too should also be mentioned clearly. Without the LPC no salary will be drawn. In case of any delay / deviation, it would be presumed that nothing is outstanding against the employee concerned and no reference in this regard after the expiry of the above stipulated time period would be made to the Zonal/Division/Unit concerned where the employee was posted earlier and the individual case will be settled based on the available records.

However, in case, anything is found outstanding later on, the concerned Head of the Zone/Division/Unit and as well as Accounts Head will be held responsible and necessary recovery shall be made from the individual concerned who is responsible for not taking immediate action within the stipulated period as mentioned above, without further reference to this effect. It is also to note that while relieving employees, in their No Demand /No Enquiry Certificate (NDC/NEC) and LPC dues and outstanding if any etc. should be depicted clearly and without this their NDC/NEC & LPC will not be entertained by the concerned Office/Unit where employees have been transferred.
