1. Turnover: Average Annual Financial Turnover on construction works during the last three years, ending 31st March of the previous financial year, should be at least 30% of the estimated cost.

- **2. Experience**: Bidder should have the experience of completion of similar works during last 7 years ending last day of month previous to the one in which tenders are invited should be either of the following.
 - (a) Three similar completed works costing not less than the amount equal to 40% of the estimated cost,

or

(b) Two similar completed works costing not less than the amount equal to 50% of the estimated cost,

or

- (c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- 3. Similar works mean: External and or Internal Electrification,LT/HT panels,HT/LT Cables,Transformer etc.and allied works in State Govt Organization or central Govt Departments and or Public Sector Undertakings
- **4. Profitability:** The applicant should be a profit (net) making firm and should not have incurred any loss in the last 2 (two) financial years or any three out of last five years ending 31st March, 2012 duly certified by Chartered Accountant.
- **5. EPF Registration:** Bidder must have valid EPF/ PF registration.
- **6. Joint Venture**: Joint Ventures are not permitted.
- 7. **Bid Capacity:** Agencies who meet the minimum qualification criteria will be qualified only if their available bid capacity is more than the total bid value. The available bid capacity will be calculated as under:-

- B = Value at current price level of existing commitments and on going works to be completed in the next 'N' years.
- **8. Credit Facility:** Agency shall have credit facility amounting to Rs. 25 Lakhs (minimum) issued from Bank during this financial year i.e.2012-13.
- **9.** NPCC reserve the right to reject any or all applications without assigning any reason thereof.
