TERMS AND CONDITIONS OF SALE

- 1. Each tender is to be accompanied with Demand Draft (Cheque will not be accepted) at the rate of 5% of tendered value in the name of National Projects Construction Corporation Limited payable at Faridabad. In the event of tenders not being accepted this amount will be refunded to the tenderer without interest. Tenders without Earnest Money Deposit will not be considered.
- 2. Reference to any deposit with the Corporation shall not be considered as Earnest Money Deposit for this tender.
- 3. The tender/offers should be kept valid for a period of two months from the date of opening of the tender.
- 4. The successful tenderers will be intimated after finalisation of tenders, calling upon them to deposit the entire cost of materials allotted to them, within the period stipulated by us, and then the tenderers should make their own arrangement including cutting, lifting and other arrangements at their cost to clear and lift the materials in lot or lots from our site/Yard, during normal working hours. Failure on their part to deposit the entire cost of materials within the stipulated period, will entail forfeiture of their entire tender deposit without any further reference/notice to them and the materials would be resold by us at our discretion.
- 5. The successful tenderers will have to pay the full sale value of materials purchased by them within 15 days of acceptance of their offer either in the form of Bank Draft or by Cash and the materials will be removed from site/Yard within 30 days of acceptance of offer.
- 6. Delivery of the materials shall be from our Site/Yard on "AS IS WHERE IS BASIS". In case the materials are not removed by the successful tenderers within the date stipulated, ground rent @ 1%(Percent) per day of delay on the value of the balance items left unclear may be levied extra at the discretion of the Corporation for further period of 60 days from the expiry of the stipulated date and thereafter unless it is decided
