## Terms & Conditions

1. The contract period shall be 12 months; however the same shall be extended further on mutual consent of both the parties.
2. The inspection vehicle shall be at the disposal of NPCC Ltd. and shall be utilized as per requirement all over the state of Chhattisgarh and Madhya Pradesh.
3. All Taxes like road tax, Insurance including workmen compensation as per motor vehicle act and other taxes as applicable from time to time during the currency of the contract shall be born by the vehicle owner.
4. All rules and regulations applicable from time to time as per motor vehicle act shall have to follow by the owner.
5. Rate should be quoted on monthly hire charge basis.
6. It will be responsibility of the vehicle Driver to get a Log Book (Provided by NPCC Ltd.) filled in & get signed by the officials performing journey. Payment will be made only after verification of Log Book.
7. Diesel will be supplied by NPCC Ltd., @ consumption of 10 KM per Liter. In case of emergency the owner shall have to arrange the diesel at his own cost and the actual cost shall be reimbursed by the NPCC Ltd. on production of original voucher by the owner.
8. The normal working hours shall be 12 hours per day.
9. In exigency of work, the vehicle will have to run beyond working hours also at owner's risk for which nothing extra shall be paid. No TA/DA shall be paid to the driver for out station duty
10. The major repair and day to day maintenance shall be arranged by the owner and maximum two days off in a month shall be given for routine maintenance especially on holidays as per convenience of NPCC Ltd.
11. In case of any extra consumption of fuel over and above the recommended as per above clause, the same shall be recovered from monthly Bill of the inspection vehicle from the owner.
12. Any other lubricants, if needed, will have to be arranged by the owner at his own cost.
13. In case of breakdown, the vehicle owner will provide a substitute vehicle at the same rate for which no extra cost shall be reimbursed by NPCC Ltd.
14. In case the owner fails to provide alternate vehicle, NPCC Ltd. shall be at liberty to arrange Inspection vehicle from other source and the amount so spent by NPCC on hiring vehicle shall be recovered from the owner.
15. Income Tax shall be deducted from the bills as per IT act applicable on that date.
16. The hire charge includes the wages of driver also.

17. NPCC Ltd reserves the right to cancel the Work Order after giving 7 days notice to the owner without assigning any reason thereof.
18. The vehicle will be parked at office premises or as directed.
19. The driver engaged by the owner should be experienced and should have a valid driving license. If the services of the driver are found unsatisfactory then in such a situation the owner shall immediately arrange suitable substitute.
