## **Qualifying Criteria:**

- 1. Agency must have at least two Architects with the valid registration from Council of Architecture with minimum experience of 05 (five) years.
- 2. Agency must have PAN and Service tax registration no. (Documentary evidence is to be submitted).
- 3. Average Annual Financial Turnover on Engg. Consultancy works during the last three years, ending 31<sup>st</sup> March of the previous financial year i.e. 2011-12, should be at least 15.00 Lac. (Documentary evidence is needs to be submitted).
- 4. Agency must have successfully executed the consultancy work for a RCC Multi-storied (G+3 or more) building with Electrical, Water supply, Sanitary, HVAC, Fire fighting, etc. all complete work of a building costing at least Rs.3800 Lacs (Three thousand eight hundred Lacs) within last five (05) years ending last day of the month previous to the one in which tender is invited.
