CORRIGENDUM No.-1

Corrigendum is made to **NIT No.: 70064/IBBW/NIT/Arch./JNV/563, dt.:12.09.2012** for the work of "Providing Engineering Services for Preparation of Detailed Project Reports (DPRs), Design, Drawing, Detailed BOQ etc. as per requirement of Project Authority for Construction of Buildings and other allied structures for Jawahar Navodaya Vidyalaya(JNVs) in the state of Mizoram & Meghalaya". In this connection following modifications/amendments are made regarding Earnest Money Deposit(EMD) & Pre Qualification Criteria in the above said NIT along with Tender Document, wherever applicable:-

- I) Earnest Money Deposit (EMD): The agency has to submit the requisite EMD amounting to Rs.1,00,000/- in place of Rs.50,000/- as mentioned in NIT & Tender Document.
- II) In the PREQUALIFICATION CRITERIA on Page 7 of 23 of Tender Document:
Clause 1.0: Agency must fulfill the following requirement for participation in the tender:
 - a) Tenderer must have completed SIMILAR WORK at least one no. for a minimum value of Rs.1900.00Lac in place of Rs.900.00Lac project value of work or two nos. each for a minimum value of Rs.1200.00Lac in place of Rs.600.00Lac project value of work or three nos. each for a minimum value of Rs.950.00Lac in place of Rs.450.00Lac project value of work in the last 7(seven) years ending on 31.08.2012 under Govt. / Semi Govt. / PSU or any other Autonomous Body. The work completion certificate/s for the same should be submitted.
 - b) Average Annual Turn over for the last three years should be not less than Rs.16.50Lac in place of Rs.400.00Lac as per the audited balance sheets.
 - c) Banker's Solvency Certificate for an amount of Rs.19.00Lac in place of Rs.450.00Lac from any bank registered with RBI should be submitted.
- III) Last Date of Sale/Submission of Tender Document extended: upto 08.10.2012 by 05.00PM / On 11.10.2012 upto 04.00PM.
Extended date of opening of Technical Bid (Envelope 1 & 2): On 11.10.2012 at 04.30PM.

All other terms and conditions shall remain unchanged. This corrigendum shall be the part of tender document (available at NIT Sl.
