## CORRIGENDUM No.-1

Corrigendum is made to **NIT No.: 70064/IBBW/NIT/BOP-MZ/WS/546, dt.:05.09.2012** for the work of "Construction of Border Out Post (BOPs) for BSF along Indo-Bangladesh Border in the state of Mizoram (20no. Packages i.e. Pkg. No. LMZ-02 to LMZ-21)". In this connection following modifications/amendments are made:

- A) The Pre Qualification Criteria i.e. the requirement for participation in the tender as mentioned in Clause No. 1.1b) at Page No.3 of the above said NIT may be read as under:
  - "Tenderer must have completed qualitative CIVIL WORKs including building works and appurtenant works such as electrification, sanitary work etc. at least one number for a minimum value of 80% of the estimated cost of work OR two nos. each for a minimum value of 50% of the estimated cost of work OR three nos. each for a minimum value of 40% of the estimated cost of work in the last 7(seven) years ending on 31/08/12 under Central Govt. Dept./State Govt. Dept./ Semi Govt. Dept. or PSU/Autonomous Body or under Limited Company of National/International repute.
  - (i) The agency should submit TDS Certificate(s) issued by the Limited Company of National/International repute.
  - (ii) The agency should submit Work Completion Certificate(s) (Credentials/s) accompanied with the copy(ies) of related Letter(s) of Award/Agreement(s). "
- B) Last Date of Sale/Submission of Tender Document extended: upto 15.10.2012 by 05.00PM / On 18.10.2012 upto 04.00PM. Extended date of opening of Technical Bid (Envelope-1): On 18.10.2012 at 04.30PM.
- C) All other terms and conditions shall remain unchanged.
