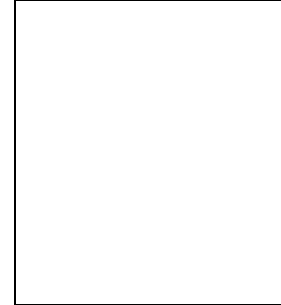
1. Mere submission of application will not entail right for claiming Appointment.
