## I. COMPANY PROFILE

National Projects Construction Corporation Limited (NPCC) is a "MINI-RATNA-I", subsidiary of WAPCOS Limited (A Government of India Enterprise) with the administrative jurisdiction of Department of Water Resources, River Development and Ganga Rejuvenation under the Union Ministry of Jal Shakti. NPCC provides project management consultancy for civil construction projects, civil infrastructure for power projects and real estate development. The corporate complies with Quality management requirements of ISO 9001-2015 for execution of Civil Works for Thermal & Hydro Electric Projects', River Valley Projects, Industrial Structures, Project Management, Consultancy services for buildings, Housings, Roads, Bridges and Infrastructure Projects.

The company employed 335 regular employees (Executives: 223 & Non-Executives:112) as on 31.03.2020.

Its Registered and Corporate Offices are at New Delhi and Gurugram respectively.

The authorised and paid up share capital of the Company was Rs.700 crore and Rs.94.53 crore respectively as on 31.03.2020.

The shareholding of WAPCOS Limited (A Government of India Undertaking-Ministry of Jal Shakti) in NPCC is 98.89%.

## II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Engineering) is a member of Board of Directors and reports to the Chairman and Managing Director. He/ She is responsible for Strategic Planning, efficient operations and Business Development activities of the Corporation for achieving its Corporate Objectives and performance parameters. He/ She is responsible for project monitoring and will ensure completion of projects within the time schedule while maintain the quality of projects . He/ She will coordinate with the clients and maintain cordial relations between employees, clients and contractors. He/ She will periodically visit project sites to ensure projects implementation and develop new business from existing and new clients in order to strengthen the order booking. He/ She will undertake regular follow up for realization of payments from clients.

### III. ELIGIBILITY

### 2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and **not** in a contractual/ad-hoc capacity – in one of the followings:-

- (a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);
- (b) Central Government including the Armed Forces of the Union and All India Services;
- (c) State Public Sector Enterprise (SPSE) where the annual turnover is **\*Rs 1000 crore or more**;
- (d) Private Sector in company where the annual turnover is **\*Rs 1000 crore or more. Preference would be given to candidates from listed companies.**

*(\* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)*

### 3. QUALIFICATION:

The applicant should be a civil engineering graduate from a recognized University/ Institution with good academic record.

Applicants holding full time MBA/ Post Graduate Diploma in Management will have an added advantage.

### 4. EXPERIENCE:

The applicant should possess adequate experience at a senior level of management in a large organization of repute.

Experience in dealing with heavy engineering projects, dams, tunnels, barrages, hydel /thermal power stations, industrial structures, fabrication and erection of steel structures etc. would have

added advantage.

## **5. PAY SCALE:**

The minimum length of service required in the eligible scale will be one year for internal candidates, and two years for others as on the date of vacancy.

### **(b)**

**(i) Applicants from Central Government / All India Services** should be holding a post of the level of Director in Government of India or carrying equivalent scale of pay on the date of application.

**(ii) Applicants from the Armed forces of the Union** should be holding a post of the level of Brigadier in the Army or equivalent rank in Navy/Air Force on the date of application.

### **(c)**

**Applicants from State Public Sector Enterprises/ Private Sector** should be working at Board level position or at least a post of the level immediately below the Board level on the date of application.

## **6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS**

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

## **IV. DURATION OF APPOINTMENT**

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

## **V. SUBMISSION OF APPLICATIONS**

- (d) CMDs/MDs/Functional Directors in State PSE: through the concerned Administrative Secretary and Cadre Controlling Authority, if any, of the State Government;

(e) Below Board level in SPSE: through the concerned SPSE;

(f) Private Sector: directly to the PESB.

2. Applicants from Private Sector must submit the following documents along with the application form:

(a) Annual Reports of the Company in which currently working for the 3 financial years preceding the calendar year in which the post is advertised (**please provide URL or attach/enclose copies**);

(b) Whether the company is listed or not; if yes, documentary proof (**please provide URL or attach/enclose copies**);

(c) Evidence of working at Board level or at least a post of the level immediately below the Board level;

(d) Self-attested copies of documents in support of age and qualifications;

(e) Relevant Jobs handled in the past with details.

## **VI. UNDERTAKING BY THE APPLICANT**

An applicant has to give an undertaking as a part of the application that he/she will join the post, if selected. If an applicant does not give such undertaking, the application would be rejected.

### **1. For candidates from Central Government/Armed Forces of the Union/ All India Services**

(a) The appointment is on immediate absorption basis.

(b) If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

(c) Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

### **2. For candidates from CPSE**

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

### **3. For candidates from SPSE/ Private Sector**

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
