

Subject: Departmental inquiry against Shri M.P. Singh, Executive Engineer (Civil), National Projects Construction Corporation Ltd.

In compliance of the order made on 14.08.2014, the presenting officer reported that a notice was published in "The Times of India" dated 17.01.2015 [New Delhi/Gurgaon Edition, New Delhi/Noida/Ghaziabad edition, Lucknow Edition, Kanpur Edition & New Delhi Edition] and dated 18.01.2015 [Agra Edition] stating that the inquiry in the abovementioned case would be held in the premises of NPCC at Faridabad on 06.02.2015; and that if the charged officer fails to appear on the appointed date and time, the inquiry will be held ex-parte. Despite that, the charged officer has neither appeared in the inquiry, nor did he send any communication about his absence. Thus, the undersigned has decided to proceed ex-parte in the case.

3. The presenting officer submitted original documents listed in Annexure-III to the charge memorandum. Those were taken on the records of inquiry as *Exhibits P-1 to P-4*.

4. There is only one witness, namely Shri V.V. Sharma, GGM(C), NPCC Ltd., on behalf of prosecution. His evidence would thus be recorded at 1030 hrs. on 27.02.2015 in the Conference Hall, NPCC Ltd., Plot No. 67-68, Sector-25, Faridabad. The presenting officer will inform the witness accordingly. If the charged officer fails to appear on the appointed date and time, the inquiry will be held ex-parte.


