ORDER

Whereas, Shri Raman Prakash Gupta has been given the offer of appointment for the regular post of Deputy General Manager (Engg.) in NPCC vide letter no. 500160/RP/DGM (Civil)/2016/2911 dated 17th Aug., 2016 and he joined NPCC on 04.01.2017 (FN) at Corporate Office, Faridabad. Shri Raman Prakash Gupta was posted in Contracts, Marketing & Works(CM&W) Division vide office order no. 500202/T/744 dated 05.01.2017. Further, he was transferred to Trivandrum Zone vide order no. 500202/T/928 dated 24.10.2018.

And whereas, as per clause no. 5 of his offer of appointment, he is on probation for a period of one year which will be confirmed based upon his satisfactory performance and conduct. During probation period his services are liable to be terminated at any time without assigning any reasons thereof on either side with one month's notice or pay in lieu thereof. Shri Raman Prakash Gupta is still continuing his services on probation, as the same has not been yet confirmed.

And whereas, during his probation his performance and conduct has not been found satisfactory and I am of the opinion that to keep him in services further will not be desirable for the Corporation.
