The selection procedure will be decided by NPCC depending upon the response received against each post. The selection criteria can be by way of Personal Interview or by any other appropriate way. Decision of NPCC will be final in this regard. The final selection of the candidates will be based on the performance in the interview, or by any other appropriate way, whereafter the "Offer of Appointment" shall be issued. Selected candidates will be on probation for one year.

### **GENERAL**

- 1. Only Indian Nationals should apply.
- 2. Applicant from Non Government Sector should necessarily be from PUBLIC LISTED COMPANY ONLY (Stock Exchange).
- 3. For internal candidates while there will be no relaxation in minimum experience, the requirement of working in next below grade for internal candidates is one year as against two years for others.
- 4. All qualifications should be obtained from an Indian University / Institute approved/recognized by UGC/AICTE. The requisite educational qualification is CA from the Institute of Chartered Accountants of India/CMA from the Institute of Cost Accountants of India.

- 5. Candidates applying for more than one post should apply separately for each post.
